1. Introduction

The Jean Monnet Centre of Excellence was created in 2003 with the financial support of the European Commission under its [Jean Monnet Action](#) and co-funded by the University of Manchester. At the end of a three-year funding period its focus was broadened away from its initial concern with the European Union to European Studies more generally. At the same time, the JMCE became more broadly based with partners from the University of Manchester and Manchester Metropolitan University and other local organisations.

The JMCE aims to provide a platform for European Studies-related activities and research in Greater Manchester and the North West of England. The Centre aims to strengthen the intellectual community in European Studies, while also facilitating local, regional and international links with practitioners, researchers, students and others interested in European affairs.

The JMCE relies on subscriptions from its principal stakeholders for its operation and is grateful for their continuing support.

The following pages report specifically on the structure and achievements of the Centre during the academic year 2022-23. This year, the JMCE has continued adjusting to the new realities of post COVID-19 academic life. As the new Director of the Centre, my focus has been on continuing to navigate the Centre through this transition. In Semester I, we retained a hybrid format for our seminar series. In Semester II, all of our activities reverted to a face-to-face format, as we actively shape and promote a vibrant and Manchester-based community of scholars and thinkers of Europe.

In the coming academic year, the JMCE will be welcoming a new Deputy Director, Dr Davide Schmid (MMU)! You can find out more about Davide's profile inside this report. We are also transitioning to a new administrator, Stanley Wilshire, who has already worked to support our Semester II events this academic year.

In terms of our strategy, we see the JMCE as the natural space to promote European Studies in Manchester and the UK, and to promote the standing of Manchester and UK-based researchers in the field of European Studies. We are therefore planning to extend our bursary schemes in order to more extensively support the intellectual community for European Studies in Manchester and the North of England. We will also engage in joint activities with other research institutes and policy-facing institutes and organisations in order to expand and consolidate this space. 



4.2. The JMCE Annual Lecture 2023

The 2023 Annual Lecture took place in the form of a Roundtable as part of our commitment to actively engaging civil society, policy-makers and local communities in how academics reflect on, debate and study Europe and European issues.

This year's theme was "The Spectre of a Nuclear Threat in Europe".

We welcomed three very distinguished panellists to the JMCE to discuss with us:

[Dr Rebecca Johnson](#) is an ecofeminist peace activist who is executive director of the Acronym Institute of Disarmament Diplomacy and founding president of the International Campaign to Abolish Nuclear Weapons (ICAN) who won the 2017 Nobel Peace Prize.

[Professor Holger Nehring](#) is a specialist in the history of Cold War military infrastructure and social movements at the University of Stirling.


[Sebastian Brixey-Williams](#) is executive director of and researcher, facilitator and mediator for BASIC, an independent think tank that aims to safeguard humanity and the Earth's ecosystem from nuclear risks and interconnected security threats and has a global reputation for promoting dialogue among states, including hostile states, in accordance with this mission.

We had an excellent discussion with participants from both of our university communities, as well as local and transnational civil society and local policy-makers. We also held a very engaging closed-door workshop after the Roundtable bringing together our speakers with interested colleagues and PhD students.



4.3. Special Events

We held one special event in Semester I in the form of a book presentation and one special event in Semester II to mark the 25th anniversary of the Good Friday Agreement.

PhD Bursaries:

Angel Martin Caballero (AMBS, UoM): Fieldwork to Madrid, Spain



Angel said: “The experience exceeded my expectations and enriched me in numerous ways. I had the privilege of meeting fascinating individuals both within and outside the academic sphere. At UAM, the professors were incredibly generous and assisted me in establishing connections with various trade union and business representatives. I also had the chance to present my preliminary findings at two academic events—an engaging seminar organised by the Digital Economy Research Centre of UAM and a session hosted by the Department of Sociology. In both settings, I received valuable feedback and established connections with prominent researchers in my field.”

Daniel Stratford (Chester): Fieldwork in Spain. David said: “Without Manchester JMCE, fieldwork would not have been possible. Manchester JMCE supported the funding of fieldwork to Ibiza in April 2023, from which my thesis saw new developments and exciting research trajectories, such as understanding street drug dealing from the perspective of Islam. Beginning in October 2021, I aim to submit my thesis in September 2024.”

Workshops:

Aida Fernández Prieto & April Pudsey (MMU): Poverty and Vulnerability in Classical Antiquity: Gendered and Life-Cycle Approaches

This two-day conference hosted at MMU featured two prestigious key-note speakers, Professor Violaine Sebillotte-Cuchet (l'Université Paris 1 Panthéon-Sorbonne) and Dr Claire Holleran (University of Exeter), and brought together, in hybrid format, 24 speakers from the UK and other institutions overseas (Spain, Greece, Finland, Switzerland, the USA and Colombia), as well as a significant number of attendants (both postgraduate and PhD students and established academics).



Olga Onuch and Alina Nychyk (SoSS, UoM): Russia's War Against Ukraine



On 19th June 2023, a workshop “Russia’s War Against Ukraine: Resistance, Reform and Reconstruction” was held at the University of Manchester. Among other funders, the workshop was also supported by Jean Monnet Centre of Excellence funds.

The organisers (Dr Alina Nychyk, Prof Olga Onuch and Dr Emma Mateo) managed to gather the most prominent Political Science scholars working on Ukraine: Prof Gwendolyn Sasse, Dr Lenka Bustikova, Dr Tymofii Brik, Prof Paul D’Anieri, Dr Inna Melnykovska, Dr Maria Popova, Prof Anastasia Shesterinina, Prof Gulnaz Sharafutdinova, Dr Oxana Shevel, Prof Kataryna Wolczuk and many others. Although some scholars joined online from Canada, US or UK, others were able to travel to Manchester (e.g. Prof Paul D’Anieri travelled from the University of California), which facilitated scientific exchange and networking over the lunch and dinner.

The aim of the workshop was to present 6 papers that make major empirical (and policy relevant) contributions to the contemporary study of Russia’s war against Ukraine and Ukraine’s recovery and reform challenges in the context of all-out war. 3 key voices in the discipline responded and discussed the papers, thus, promoting further dialogue. The immediate aim is to publish the set of papers and discussant essays as a symposium in a leading journal. In this way, after the workshop, participants stay in touch working on the Special Issue.




5. News

5.1. Meet the new JMCE Deputy Director!




Dr Davide Schmid is Senior Lecturer in International Relations at Manchester Metropolitan University. His areas of specialism are Critical Theory and International Political Economy. In his research, he addresses the Frankfurt School tradition of critique and the analysis of contemporary capitalist crisis in relation to European integration and the European border regime. He published his research in high-ranking academic journals such as *The European Journal of International Relations*, *Geoforum*, the *Journal of European Public Policy*, the *Journal of Common Market Studies* and *Geopolitics*. His monograph, *The Poverty of Critical Theory in International Relations*, is published with Palgrave Macmillan (2023).
